A fee may be charged for any such paper copy, subject to our Schedule of Fees and Charges.

You agree to provide and maintain a valid and active email address. You may update your email address from your profile tab in Digital Banking following these steps:

Desktop Browser: Select your profile from the left margin at the bottom of your screen where your name is displayed. Select Settings and edit your contact information.

Mobile App: Select the menu in the upper left corner of your screen, click on your name in the bottom left corner of your screen. Next, select settings. Next click on your name/username at the top of your screen and update your contact information.

Deere Employees Credit Union is not liable for any third-party incurred fees, other legal liability, or any other issues or liabilities arising from statements or notifications sent to an invalid or inactive email address that you have provided.

To receive and review statements, you must have an Internet-capable computer with the latest version of your Internet browser. In addition, you must also be able to view Adobe Acrobat version 8.0 or higher (PDF) files. You may download Acrobat for free from Adobe's website.

In addition, you affirm that you either have a printer capable of printing any electronically provided statements, or you have the ability to save and display any such statements.

You will receive a statement at least quarterly. You will be notified electronically via email or if you elected via text to your mobile phone, when your statement is available. Upon receipt of the email, you may retrieve the statement through Online Banking using your Online Banking User ID and password.

It is recommended that you print a copy of any electronically provided statements or disclosures (including this one) for your records.
